On 4/21/2023, upon partial settlement of an equity swap agreement entered into by the reporting person and a securities broker on 11/30/2021, the reporting person paid to the broker \$24.6301 per share for each of 882 shares subject to the settlement, offset by \$20.5784 per share (the market price of the shares on 4/21/2023) for each of the 882 shares subject to the settlement. After the partial settlement, 64.651 notional shares of PTMN common stock remained subject to the equity swap agreement.
